## **UNAUDITED OPERATING STATISTICS FOR JUNE AND FIRST HALF YEAR OF 2016**

The board of directors (the “Board”) of Longfor Properties Co. Ltd. (the “Company”, together with its subsidiaries, the “Group”) is pleased to announce that, at the end of June 2016, the Group achieved aggregated contracted sales of RMB38.59 billion, representing y-o-y growth of 78.3%, contracted sales in terms of GFA amounted to 2,557,000 sq.m.. In June 2016, the Group recorded contracted sales of RMB8.39 billion, with contracted sales in terms of GFA amounting to 531,000 sq.m..
