The board of director of Longfor Group Holdings Limited (the “**Company**”) has been informed by Charm Talent International Limited (“**Charm Talent**”), a substantial shareholder of the Company, that Charm Talent acquired 2,000,000 ordinary shares of the Company (the “**Shares**”) on the open market at an average price of approximately HK\$45.00 between 3 June 2021 and 4 June 2021 (the “**Acquisition**”).

The entire issued share capital of Charm Talent is wholly-owned by Silver Sea Assets Limited (“**Silver Sea**”), the entire issued share capital of which is in turn wholly owned by HSBC International Trustee Limited as the trustee of the XTH Trust.

Immediately prior to the Acquisition, Charm Talent was interested in 2,587,778,201 Shares, representing approximately 42.67% of the total issued share capital of the Company as at the date of this announcement.
