(the “Company”, together with its subsidiaries, the “Group”) is pleased to announce that, up to February 2018, the Group achieved aggregated contracted sales of RMB29.27 billion, representing y-o-y growth of 20%, contracted sales in terms of GFA amounted to 1,924,000 sq.m.. In February 2018, the Group recorded contracted sales of RMB13.25 billion, with contracted sales in terms of GFA amounting to 769,000 sq.m..
