UNAUDITED OPERATING STATISTICS FOR JUNE AND FIRST HALF YEAR OF 2017

The board of directors (the “Board”) of Longfor Properties Co. Ltd. (the “Company”, together with its subsidiaries, the “Group”) is pleased to announce that, as at the end of June 2017, the Group achieved aggregated contracted sales of RMB92.63 billion, representing y-o-y growth of 140%, with contracted sales in terms of GFA amounted to 5,950,000 sq.m.. In June 2017, the Group recorded contracted sales of RMB16.88 billion, with contracted sales in terms of GFA amounting to 1,048,000 sq.m..
