UNAUDITED OPERATING STATISTICS FOR SEPTEMBER 2017

The board of directors (the “Board”) of Longfor Properties Co. Ltd. (the “Company”, together with its subsidiaries, the “Group”) is pleased to announce that, at the end of September 2017, the Group achieved aggregated contracted sales of RMB128.23 billion, representing y-o-y growth of 97%, with contracted sales in terms of GFA amounted to 8,336,000 sq.m.. In September 2017, the Group recorded contracted sales of RMB13.14 billion, with contracted sales in terms of GFA amounting to 907,000 sq.m..
